



**2021-22 EXTENDED CHILD CARE – BOBCAT CLUB: PAID MONTHLY**

Notify the school office in writing prior to any daycare changes.  
Daycare is billed monthly by the daycare coordinator and paid to the school office.  
Make checks payable to Beatitudes School.  
\$30 Returned Check Fee.  
\$30 Late Fee.  
Past due balances including fees are subject to being added to current FACTS account.

**FULL-TIME:** Families whose students consistently attend daycare are billed monthly the full-time rate from September through May. August and June attendance fees are absorbed in September-May billings.  
Families whose students attend full-time daycare are encouraged to add their daycare fees to their FACTS account.  
If you want to add daycare fees to FACTS, mark this on your financial contract.

**DROP-IN:** Families whose students attend occasionally are billed monthly the drop-in rate for every day attended (August-June). Any student not picked up from school or afterschool activities by pickup time will be sent to daycare and assessed daycare fees.

**MORNING HOURS: 6:30 AM UNTIL SCHOOL BEGINS.**

Morning Full-Time Fee: \$ 60 per student \$110 per family  
Morning Drop-In Fee: \$ 5 per day per student

**AFTERNOON HOURS: WHEN SCHOOL IS DISMISSED UNTIL 6 PM.**

Afternoon Full-Time Fee: \$190 one student \$245 two students \$300 three students \$350 four students  
Afternoon Drop-In Fee (M-Th): \$ 10 per day per student  
Afternoon Drop-In Fee (F/Early Dismissal): \$ 10 per day per student if picked up by 4PM, or \$20 if picked up between 4PM and 6PM

**LATE PICK UP FEE: \$ 5 PER MINUTE AFTER 6 PM.**

**HOMEWORK:** The completion of homework and studying is ultimately the student’s responsibility. Parents may or may not choose to have their child work on homework during the 45-minute study time. If you choose to not have your child work on his/her assignments, he/she will be required to have a book so he/she can read during this quiet time.

**TAX IDENTIFICATION NUMBER FOR TAXES:** Daycare costs may be tax deductible. Beatitudes of Our Lord Daycare is a 501c3 non-profit organization under the IRS rules. The IRS does not require a tax ID number from non-profit organizations, and it is Archdiocesan policy not to release tax identification numbers. If you are eligible to claim this deduction, write “tax exempt” where the tax identification number is requested.
